# **Notice of Consent Application**

On 13 April 2021, He Korowai Trust lodged a consent application with the Environmental Protection Authority (EPA) for the Papakāinga Development - Kaitaia under the COVID-19 Recovery (Fast-track Consenting) Act 2020 (the Act). ### Your comments must be returned to the EPA no later than 7 July 2021

Please note that there is no right for you (or any other person) to seek a waiver of this time limit.

Please note that under clause 18 (3) of Schedule 6 of the Act.

An iwi authority invited to provide comments under clause 17(2) may—

- a) share the consent application or notice of requirement with hapū whose rohe is in the project area proposed in the application or notice; and
- b) choose to include comments from that hap  $\bar{u}$  with the comments provided to the panel by the iwi authority.

The EPA will forward copies of any comments received to He Korowai Trust and the Panel.

If you comment on the application, the Panel will also invite you to comment on the draft conditions at a later stage. If you do not comment on the application you will be sent notice of the decision on the application when it is made.
