**Notice of Consent Application**

On 12 November 2021, Thames Coromandel District Council lodged a consent application with the Environmental Protection Authority (EPA) for the Kōpū Marine Precinct under the COVID-19 Recovery (Fast-track Consenting) Act 2020 (the Act). On 19 November 2021, the EPA determined that it complied with clause 3(1) and it was referred to the Kōpū Marine Precinct Expert Consenting Panel (the Panel) for processing and decision.

Under the Act, the Panel must invite comments from specified identified parties, including those parties listed in a referral order. You are identified under clause 7 of Schedule 19 of the COVID-19 Recovery (Fast-track Consenting) Referred Projects Order 2020.

Please note that public or limited notification is not allowed under the Act.

## **Your comments must be returned to the EPA no later than 1 February 2022**

Please note that there is no right for you (or any other person) to seek a waiver of this time limit.

The EPA will forward copies of any comments received to Thames Coromandel District Council and the Panel.

If you comment on the application, the Panel will also invite you to comment on the draft conditions at a later stage. If you do not comment on the application, you will be sent notice of the decision on the application when it is made.
