Notice of Consent Application

On 19 November 2021, Melia Development Limited lodged a consent application with the Environmental Protection Authority (EPA) for Melia Place under the COVID-19 Recovery (Fast-track Consenting) Act 2020 (the Act). On 26 November 2021, the EPA determined that it complied with clause 3(1) and it was referred to the Melia Place Expert Consenting Panel (the Panel) for processing and decision.

Please note that public or limited notification is not allowed under the Act.

The Panel invites you to comment on the above consent application. If you wish to comment on the application, please complete the enclosed form and return it to the EPA by email to meliafasttrack@epa.govt.nz, or by post or in person.

Your comments must be returned to the EPA no later than 28 February 2022.

Please note that there is no right for you (or any other person) to seek a waiver of this time limit.

The EPA will forward copies of any comments received to Melia Development Limited and the Panel.

If you comment on the application, the Panel will also invite you to comment on the draft conditions at a later stage. If you do not comment on the application, you will be sent notice of the decision on the application when it is made.
