**Notice of consent applications and notices of requirement by Waka Kotahi NZ Transport Agency and Transpower New Zealand Limited, and invitation to comment under the COVID-19 Recovery (Fast-Track Consenting) Act 2020**

**Notice of Consent Applications and Notices of Requirement**

On 24 June 2021, Waka Kotahi NZ Transport Agency and Transpower New Zealand Limited lodged two notices of requirement and consent applications with the Environmental Protection Authority (EPA) for Stage 1B1 of the Papakura to Drury South State Highway 1 Improvements under the COVID-19 Recovery (Fast-track Consenting) Act 2020 (the Act). On 1 July 2021 the EPA determined that the applications and notices of requirement complied with clause 3(1) and it was referred to the Papakura to Drury South State Highway 1 Improvements Expert Consenting Panel (the Panel) for processing and decision.

**Invitation to Comment**

Under the Act, the Panel must invite comments from specified identified parties, including any requiring authority that has a designation on the land on which the project is to be undertaken or land that is adjacent to that land. You are identified as a requiring authority from whom the Panel must seek comment because you have a designation, which is on land/adjacent to the land on which the project is to be undertaken.

Please note that public or limited notification is not allowed under the Act.

The Panel invites you to comment on the above consent applications and notices of requirement. If you wish to comment on the applications and notices of requirement please complete the enclosed form and return it to the EPA by email to [papakuradrury.fasttrack@epa.govt.nz](mailto:papakuradrury.fasttrack@epa.govt.nz), or by post or in person.

**Your comments must be returned to the EPA no later than Friday, 24 September 2021.**

Please note that there is no right for you (or any other person) to seek a waiver of this time limit.

The EPA will forward copies of any comments received to Waka Kotahi NZ Transport Agency and Transpower New Zealand Limited and the Panel.

If you comment on the application and notices of requirement, the Panel will also invite you to comment on the draft conditions at a later stage. If you do not comment on the application you will be sent notice of the decision on the applications and notices of requirement when it is made.
